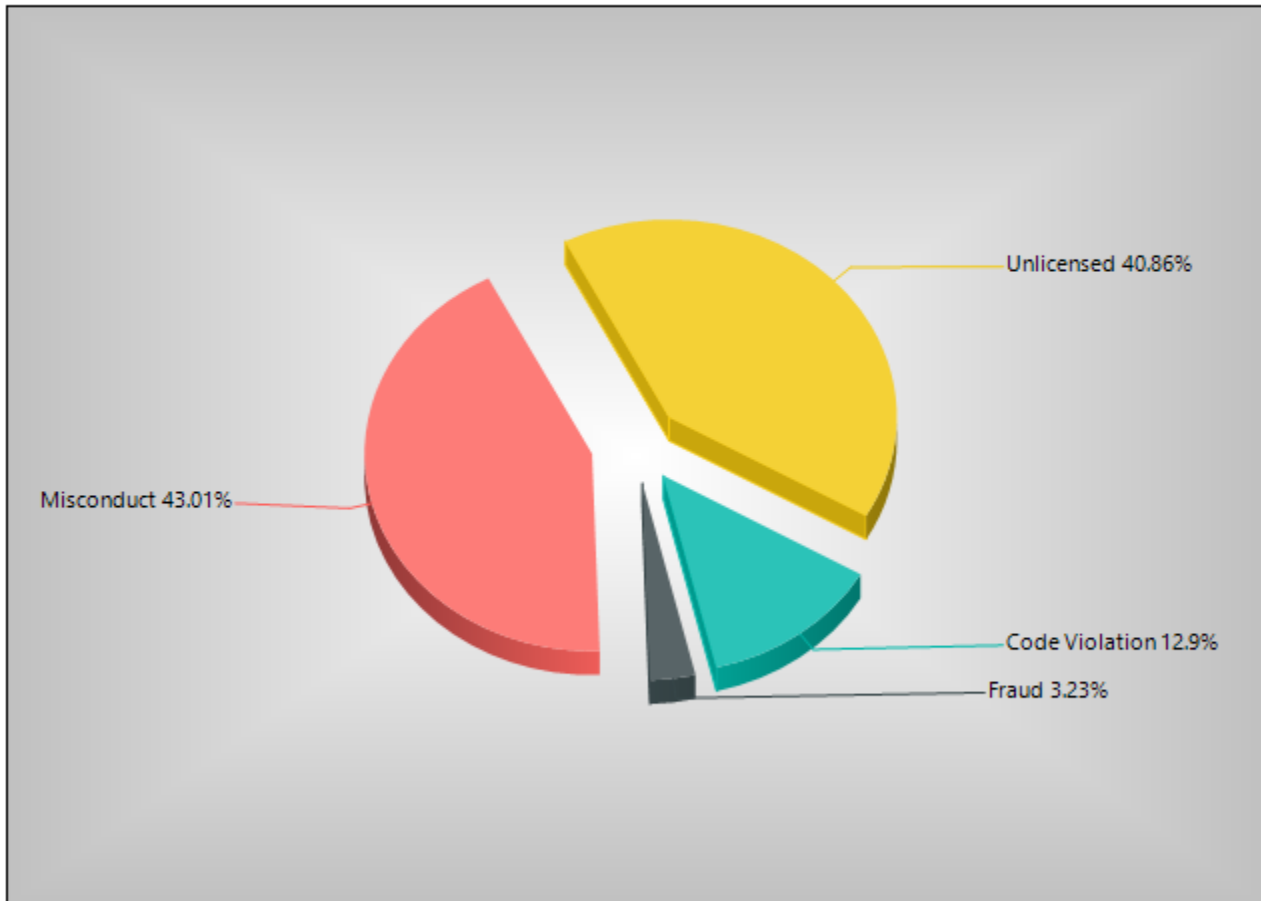


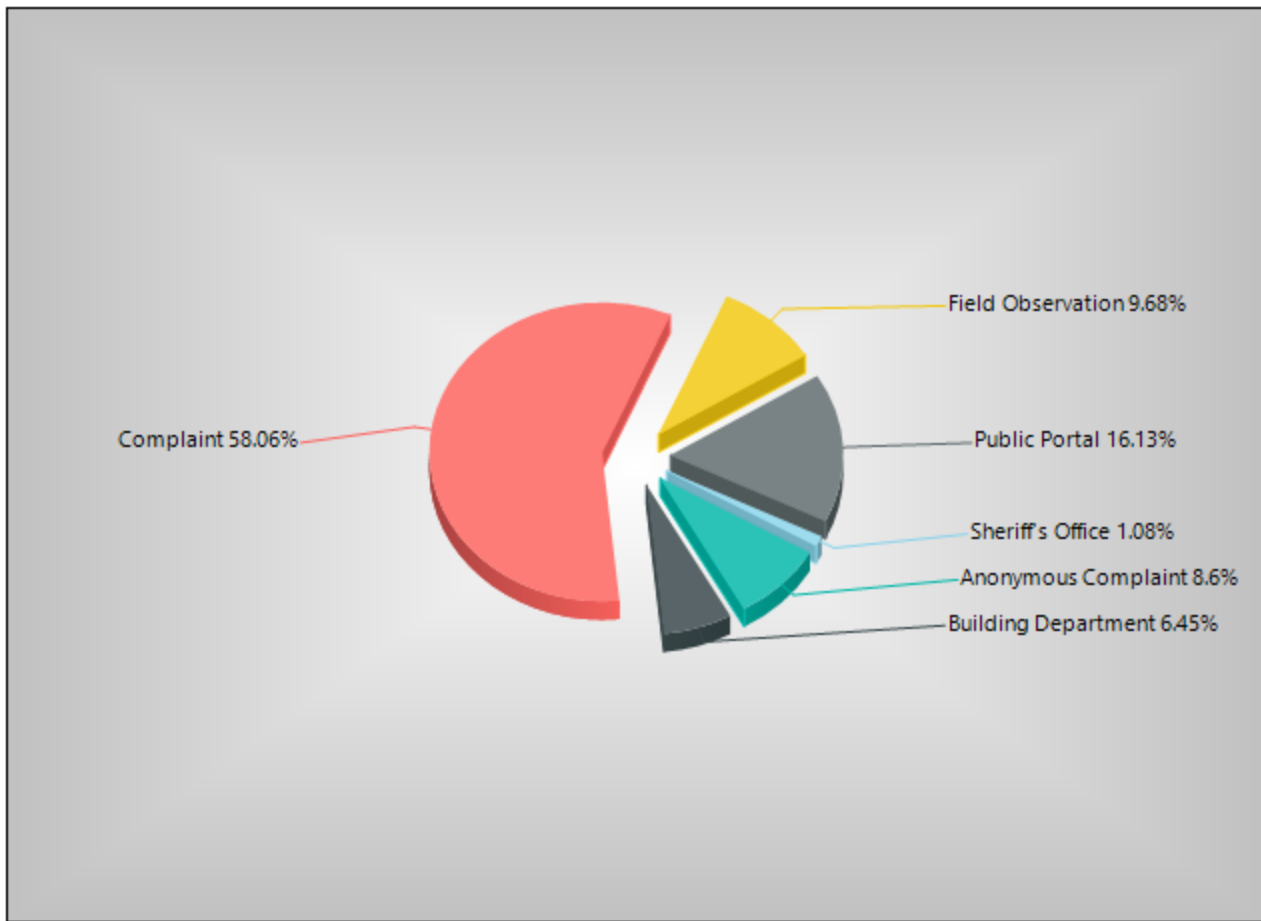

Violations by Case Type



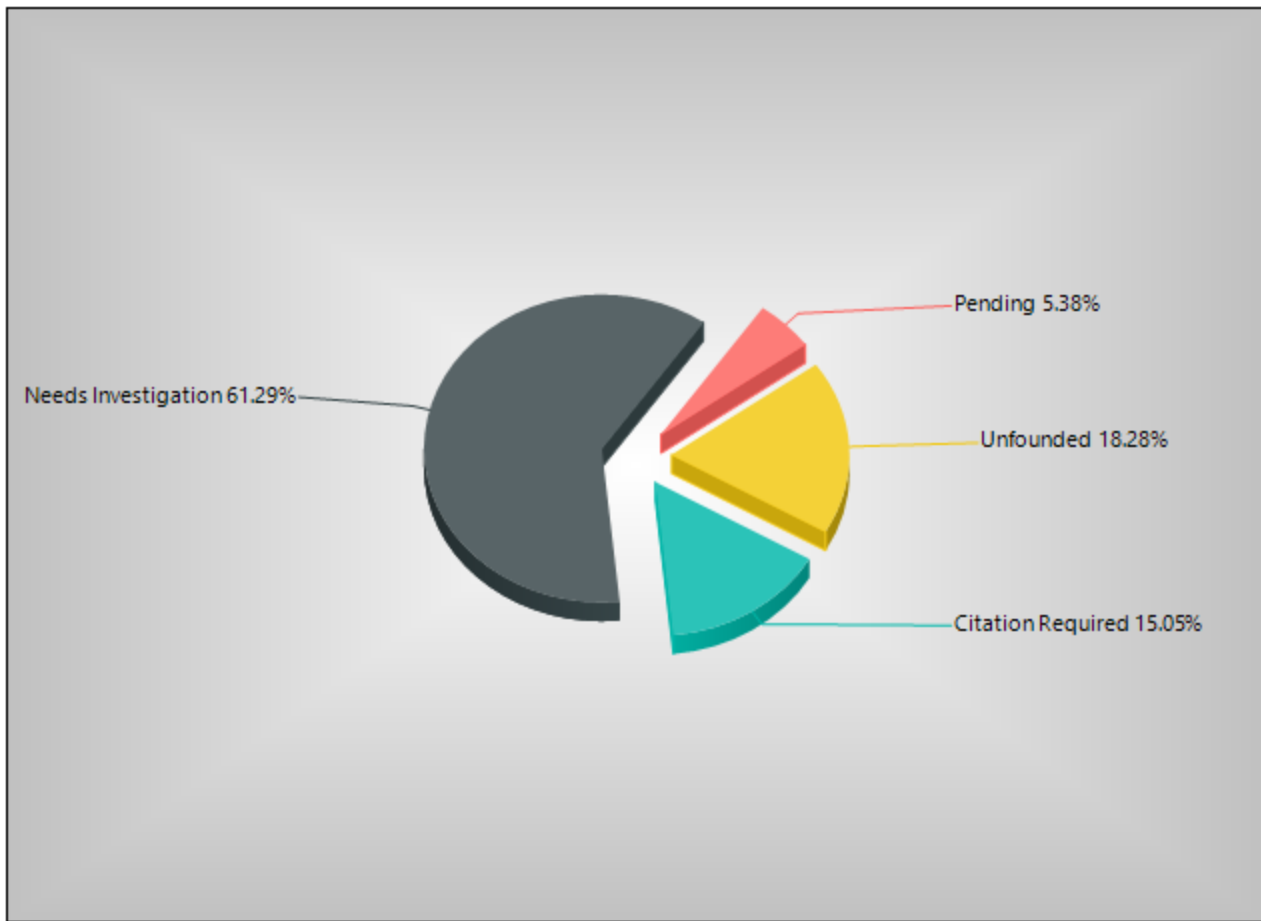

Violations by Source



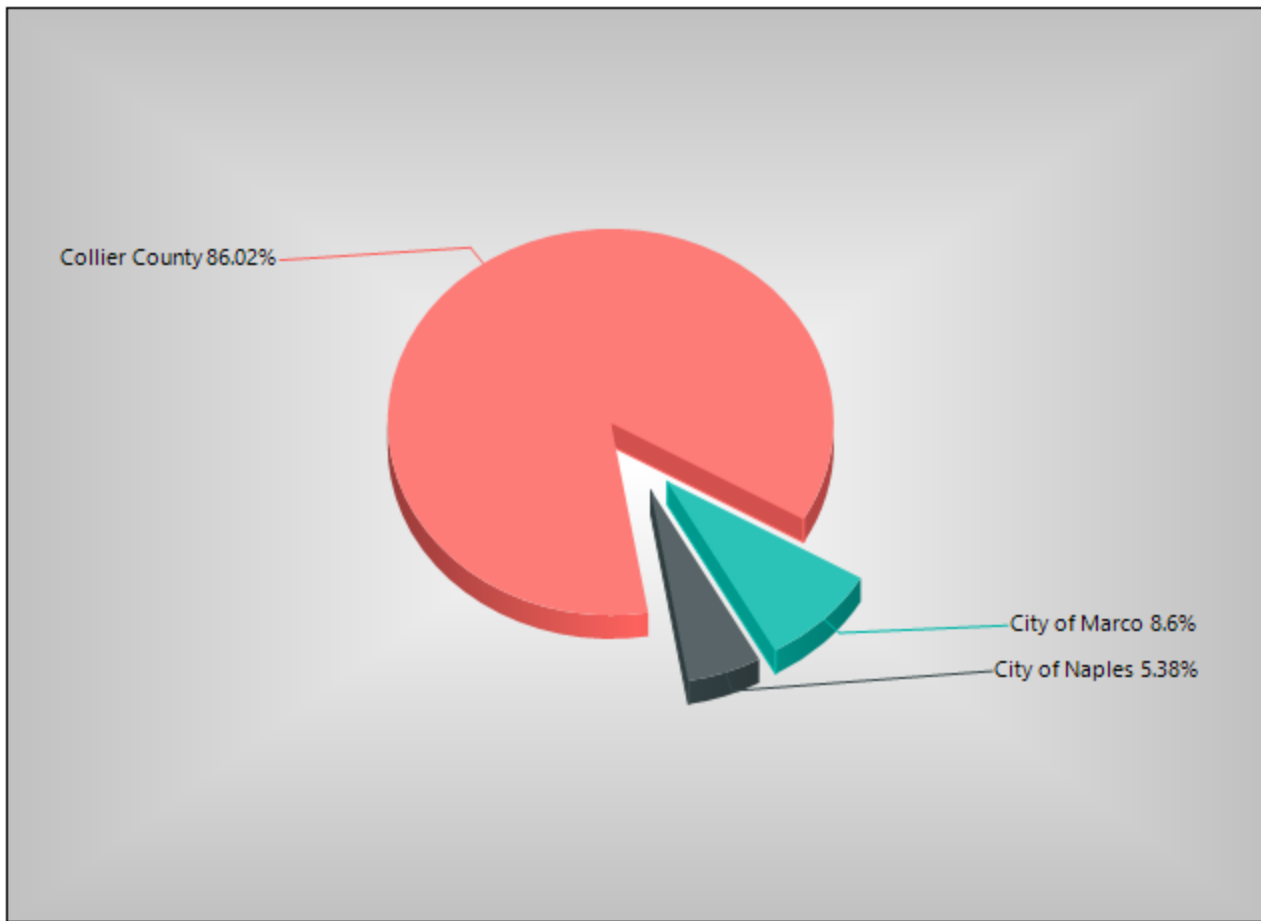
