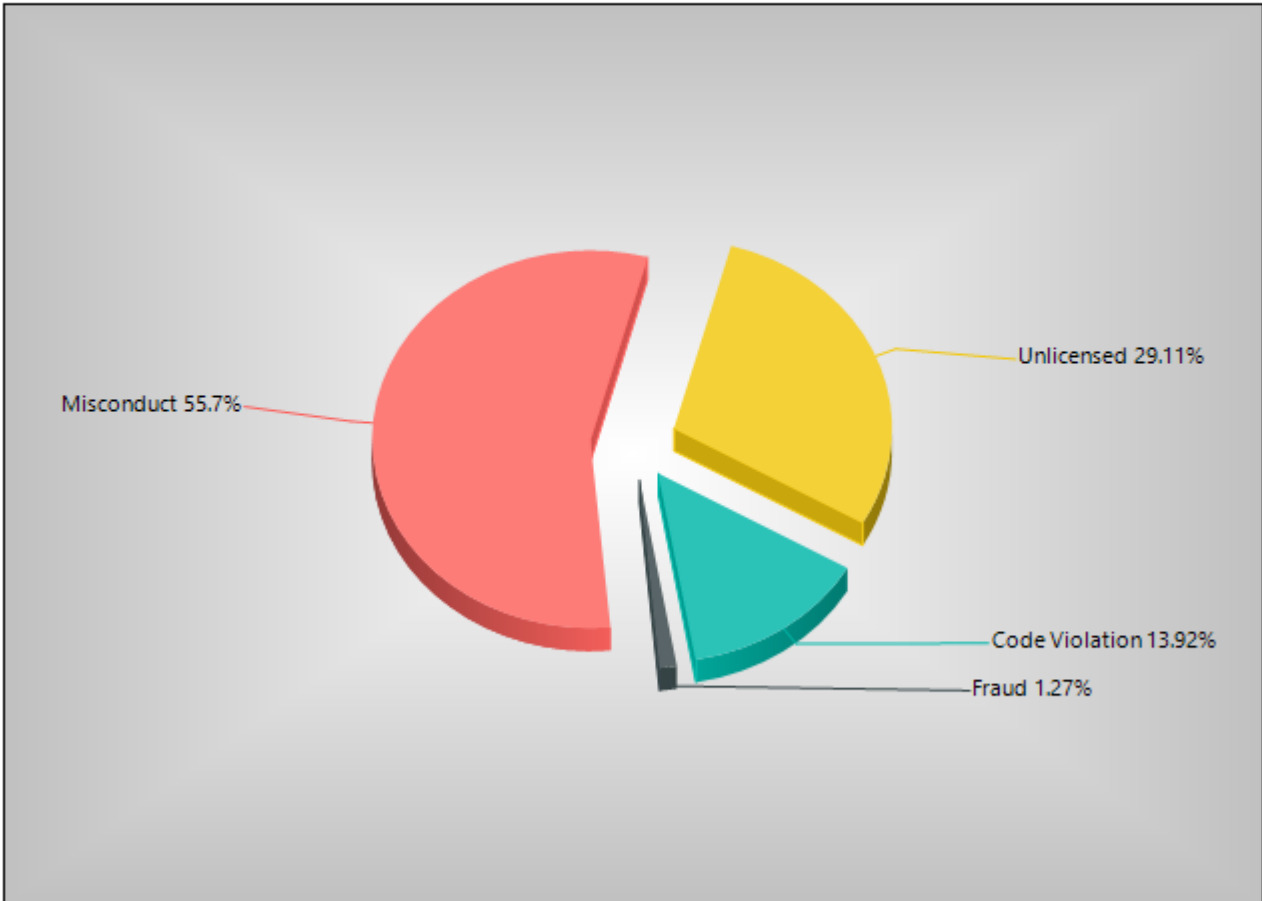


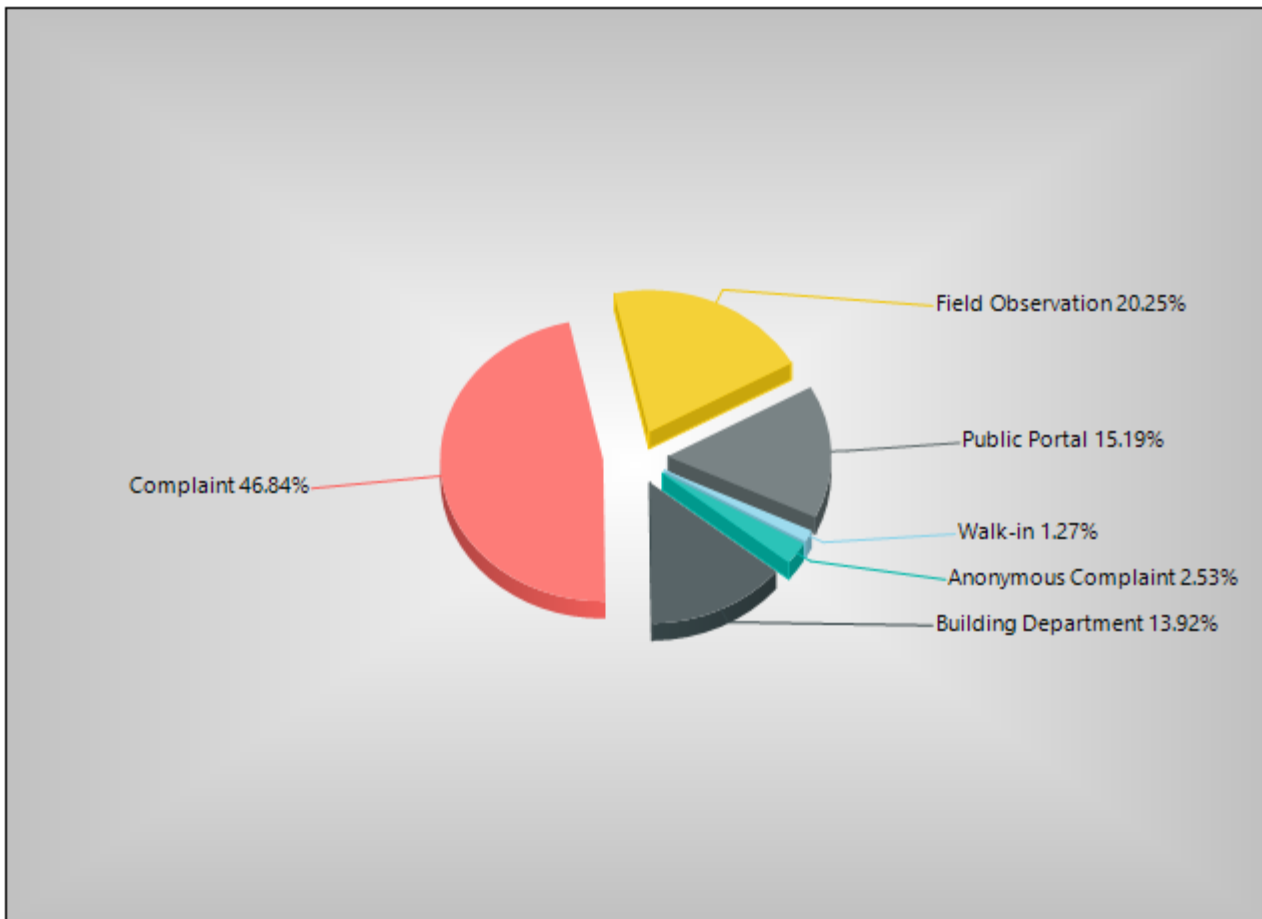

Violations by Case Type



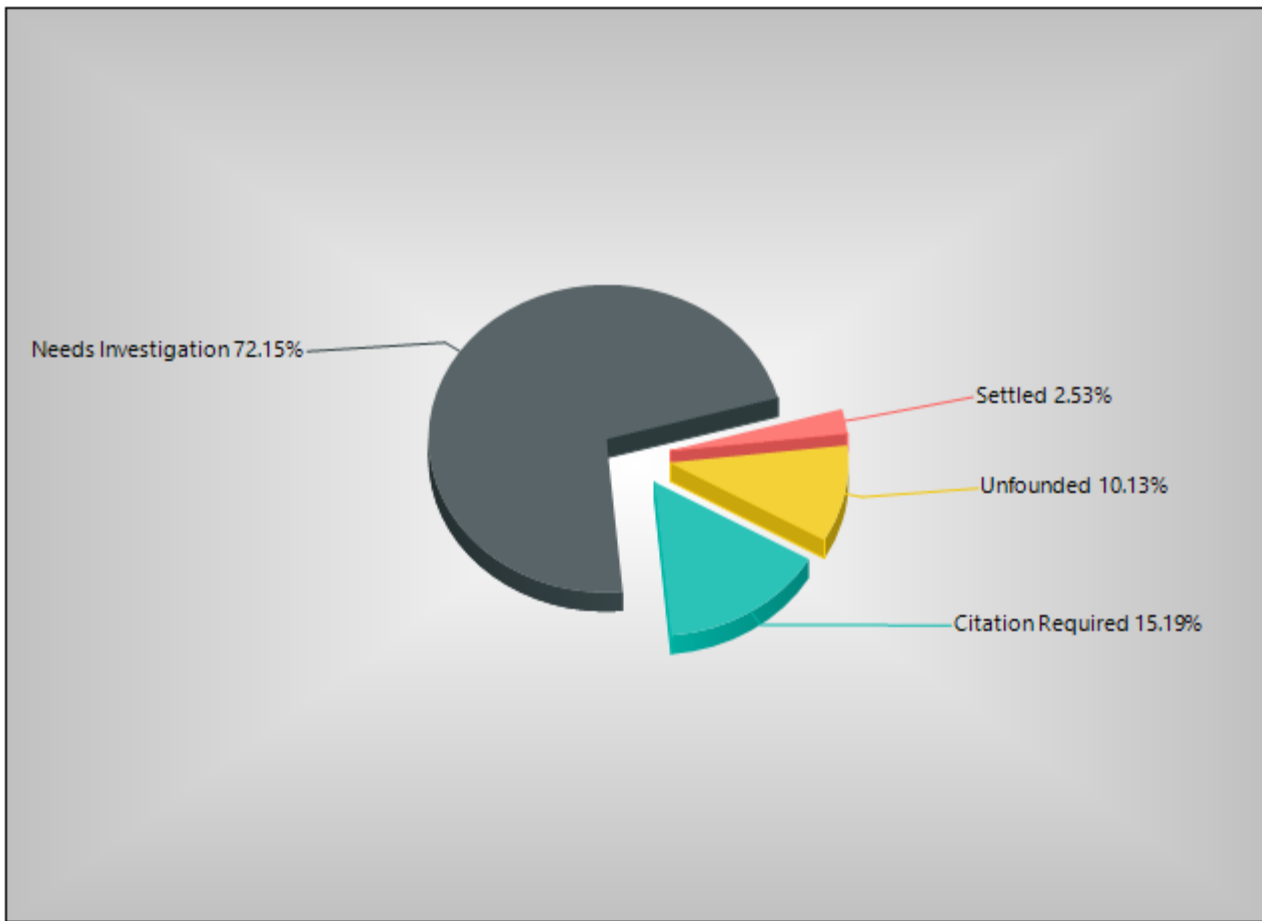

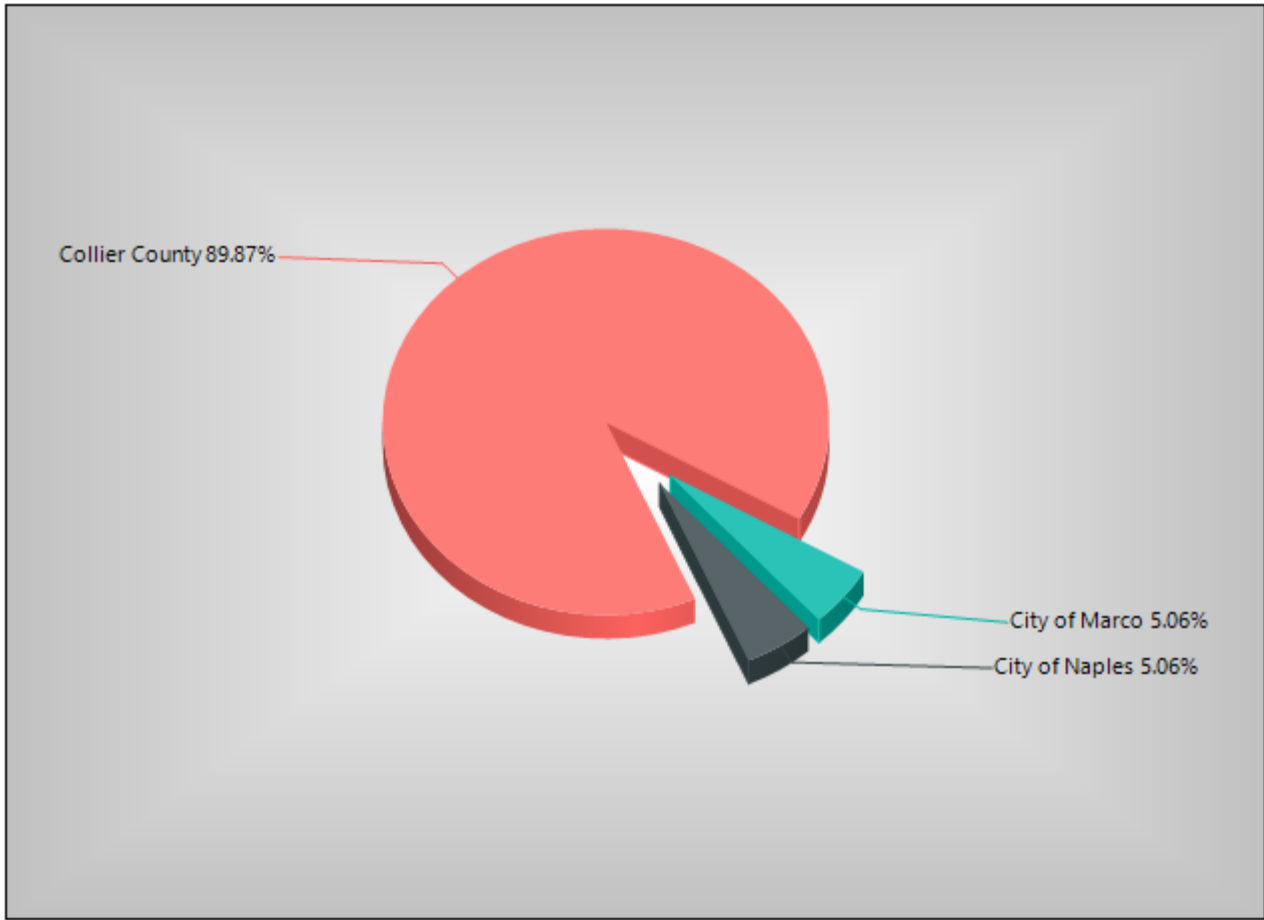
